## TERMS AND CONDITIONS

1. The camper, his/her parents and relatives agree to abide by the rules and regulations set by the Camp for the health, safety and welfare of the campers. The Camp reserves the right to dismiss a camper or family whose conduct and/or influence is detrimental to the health, safety or general operating procedures of the Camp.
2. In the event that a parent or guardian cannot be contacted, the directors reserve the right to have the camper hospitalized or to use outside medical or dental aid. All such expenses are the responsibility of the parent or guardian.
3. No reduction or allowance is made for the late arrival or the early departure of a camper.
4. Dates of camp are subject to slight modification in the event of early or late school closings.
5. Permission is granted to Jeff Lake Camp to publish any photograph, video or likeness of my child(ren) for advertising, commercial or any purpose.
6. Permission is granted to Jeff Lake Camp for my child(ren), to participate in all camp activities including camp trips.
7. Parents represent to the Camp that the camper is in sound physical and mental health and fully able to participate in all Camp activities without need of specialized attention or medical regimen and camper's health and behavior will not impact negatively on other campers or the Camp program. The Camp shall have the exclusive right and discretion to make all decisions of the camper's fitness to participate in programs, including the right to dismiss the camper.
